It is the sole responsibility of the client to secure permission of the church, synagogue and/or other officials to film the ceremony. The deposit is non-refundable if such officials prevent filming.

Kuprion Video Services will take utmost care to produce a tape/dvd of good quality. However, we will not be held responsible for circumstances beyond our control, including but not limited to power failure, equipment malfunction, and defective tape stock or client misuse of equipment. If filming is prevented due to such occurrences, all money paid will be refunded. Kuprion Video Services makes no guarantees, either expressed or implied, in regard to aesthetic qualities of the completed video.

Kuprion Video Services reserves the right to terminate contract for any reason at any time. Should Kuprion Video Services terminate the contract, all monies paid will be refunded.

The video is strictly produced for the client's private, home use only. Any duplication or broadcast (including internet use) without written consent of Kuprion Video Services is strictly prohibited.

It is the client's sole responsibility to inform Kuprion Video Services of any specific needs or changes in events.
